With this document, we aim to provide you with information in accordance with Article 13 of Regulation (EU) 2016/679 on the Protection of Personal Data ("General Data Protection Regulation" or "GDPR").



Identity of the Data Controller

The Data Controller is SANGALLI SERVOMOTORI SRL, represented by the current legal representative, with registered office and processing location at VIA F. ROSSI N. 5 - 20900, MONZA. You can contact the Data Controller via email at MASSIMO@SANGALLISERVOMOTORI.IT or by sending a letter to the above-mentioned address.

The Data Controller guarantees the security, confidentiality, and protection of the personal data it possesses, at any stage of the data processing process. The personal data collected is used in compliance with the principles of lawfulness, fairness, transparency, and relevance, and in accordance with the GDPR.

Purpose of the Processing

Your personal data will be processed for the following purposes:

- to fulfill obligations arising from a contract of which you are a party or to fulfill, before or after the execution of the contract, specific requests related to organizational, administrative, accounting, and commercial management of the contract
- to comply with legal obligations, regulations, EU legislation, or an order from the Authority, for internal statistical analysis purposes.

Your data will not be used for purposes other than those described in this information document, unless we inform you in advance and, if necessary, obtain your consent.

Legal Basis for the Processing

The legal basis for the processing of data for the above purposes is to perform a contract of which you are a party or to take pre-contractual measures at your request, or to comply with a legal obligation, or to protect our legitimate interests (e.g. pursuing statutory purposes or, if necessary, exercising and/or defending the company's rights in court). The provision of data for obligations required by law is mandatory; for other purposes, the provision of data is optional but necessary; therefore, your refusal may result in the impossibility for the Data Controller to establish the relationship, its timely execution, and the provision of related services.

Processing Methods

The processing of your personal data is carried out both through paper-based and electronic/information technology/telematic means, using the operations indicated in Article 4(2) of the GDPR, namely: collection, recording, organization, storage, consultation, processing, modification, selection, extraction, comparison, use, interconnection, blocking, communication, erasure, and destruction of data.

Subject to communications made in compliance with legal and contractual obligations, your data may be communicated to authorized persons in accordance with the provisions of the law, regulations, EU legislation, and, if necessary, for the pursuit of the specific purposes mentioned above and to the extent strictly necessary, to persons who must provide goods or services to the Data Controller, such as, for example: credit institutions, insurance companies and corporations; legal, administrative, tax, or marketing consultants who assist the company in carrying out its activities; IT or cloud service providers; agents, subcontractors, and/or subcontractors engaged in activities

related to the execution of the contract with the Data Controller; controlled, affiliated, or related companies; and always in compliance with the GDPR and for the pursuit of the above-mentioned purposes.

Data Transfer

The Data Controller does not transfer your personal data to third countries or international organizations. However, it reserves the right to use cloud services; in this case, service providers will be selected from those who provide adequate guarantees, as provided for in Article 46 of the GDPR 679/16.

Data Retention

Your collected data will be kept, from the time of receipt/update, for the above-mentioned purposes and in accordance with the applicable regulations and, in the event of judicial proceedings, for the entire duration thereof, until the expiration of the terms for the use of appeal means. In the case of processing based on consent, your data will be processed until you revoke the consent given and, subsequently, for the time strictly necessary to comply with applicable legal or regulatory obligations and in any event for the time necessary to ensure the exercise of the company's rights, even in court.

The retention period will be determined based on the evaluation of individual operations and will take place in compliance with the principles of necessity, purpose, relevance, minimization, and non-excess of the GDPR.

Rights of the Data Subject

At any time, you may exercise the following rights under Articles 15 and 22 of the GDPR against SANGALLI SERVOMOTORI SRL:

- the right to access your personal data;
- the right to rectifyyour personal data that is inaccurate or incomplete;
- the right to erasure (right to be forgotten) of your personal data;
- the right to restrict the processing of your personal data;
- the right to data portability, i.e. the right to receive your personal data in a structured, commonly used, and machine-readable format, and to transmit it to another data controller without hindrance;
