this information is provided, pursuant to art. 13 of Regulation (EU) n. 2016/679, for the Protection of Personal Data 2016/679 ("General Data Protection Regulation") (hereinafter the "GDPR"), to those who connect to this website (hereinafter, the 'Site'), owned and managed by SANGALLI SERVOMOTORI S.R.L.

Identity of the Data Controller

The Data Controller is SANGALLI SERVOMOTORI S.R.L., in the person of the legal representative p.t. with registered office and processing at VIA F. ROSSI N. 5 - 20900 MONZA. The Data Controller can be contacted at the email address MASSIMO@SANGALLISERVOMOTORI.IT or by writing by mail to the company's headquarters indicated above. The Data Controller guarantees the security, confidentiality and protection of the personal data in its possession, at any stage of the data processing process. The personal data collected are used in compliance with the principles of lawfulness, correctness, transparency and relevance and in accordance with the GDPR.

Types of data processed

The personal data processed through our Site are as follows:

Navigation data

The navigation systems and software procedures used to operate this website acquire, during their normal operation, some personal data whose transmission is implicit in the use of internet communication protocols. These are information that is not collected to be associated with identified data subjects, but which by their very nature could, through processing and associations with data held by third parties, allow users to be identified. This category of data includes IP addresses or domain names of the computers used by users connecting to the Site, URI (Uniform Resource Identifier) notation addresses of the requested resources, the time of the request, the method used in submitting the request to the server, the size of the file obtained in response, the numerical code indicating the status of the response given by the server (successful, error, etc.) and other parameters relating to the user's operating system and computer environment.

This data is used for the sole purpose of obtaining anonymous statistical information on the use of the Site and our customers' sites and to check their correct functioning, to identify anomalies and/or abuses, and is deleted immediately after processing. The data could be used to ascertain liability in case of hypothetical computer crimes against the Site or third parties.

Cookie

Cookies are information that websites you visit send and store on your computer or mobile device to be transmitted back to the same sites on your next visit. Thanks to these technologies, sites remember actions and preferences (such as login data, language preference, other display settings, etc.) so that they do not have to be re-entered on your next visit.

This Site uses the following types of cookies and offers the possibility of deselecting them, except for third-party cookies for which you will need to refer directly to the respective selection and deselection methods of their cookies.

- Technical cookies (navigation or session)

They are strictly necessary for the functioning of the Site, to display content on the device used or to use the requested content and services. By disabling technical cookies, the Site may not be consultable or some services or certain functions may not be available or may not work properly, and the user may be forced to manually modify or enter some information or preferences every time they visit the Site.

- Functional cookies

They allow the Site to remember choices made (storing the user's username, selected language, etc.) in order to optimize and provide more advanced features. Such cookies do not collect information that personally identifies the user. Disabling such cookies may reduce or make some Site features unavailable.

Purpose of processing

The personal data of users will be processed for the following purposes:
technical and functional access to the Site, ensuring the correct functioning of web pages and their contents;
statistical and navigation analysis purposes;
providing the goods and/or services requested by the user, managing contracts entered into by the user, carrying out related administrative, accounting, tax and legal obligations as well as fulfilling requests made by the user.
The provision of data is optional; however, it should be noted that the refusal/deactivation of cookies may prevent the use of certain Site features.

Legal basis

The legal basis for processing data for the purposes indicated is to fulfill a contract of which the data subject is a party or to take pre-contractual measures at the request of the data subject. The processing of the data in question, as it is aimed at fulfilling requests of the data subject and/or concluding and fulfilling contracts with the same, does not require the express consent of the user.

Processing methods

The processing of personal data will take place in full compliance with the principles of confidentiality, correctness, necessity, relevance, lawfulness and transparency imposed by the GDPR. The processing of personal data will be carried out mainly using electronic tools, in compliance with the current regulatory provisions. Appropriate security measures will be observed to prevent the loss of personal data, misuse or incorrect use thereof, or unauthorized access.

Recipients of the data

The collected data will not be disseminated and may be communicated, in addition to subjects to whom the possibility and interest in accessing your personal data is recognized by laws or secondary and/or community regulations, to internal personnel of the Data Controller as well as to companies, associations or professional studios that provide services and activities on behalf of the Controller.

Transfer of data

The Data Controller does not transfer the personal data of the data subject to third countries or international organizations. However, it reserves the right to use cloud services; in this case, service providers will be selected from among those who provide adequate guarantees, as provided for in art. 46 GDPR 679/16.

Data retention

The collected data will be stored, from their receipt/update, for the time strictly necessary to achieve the above-mentioned purposes and in any case in compliance with the law. After this period, the data will be deleted and/or anonymized in such a way as not to allow, even indirectly or by linking to other databases, the identification of the data subjects, without prejudice to the need to keep the data to respond to obligations provided for by applicable laws even after the cessation of processing operations.

Data Subject Rights
